# CATEGORIES OF MEMBERSHIP



**IOGANY has the following categories of membership:  
Company membership includes one named individual as a member who will be  
the company representative.**

<b>Producers Small:</b>	Those who operate, develop and produce 50 or fewer oil and/or natural gas wells, including producing gas utility companies and integrated oil companies.
<b>Producers Medium:</b>	Those who operate, develop and produce 51 – 300 oil and/or natural gas wells, including producing gas utility companies and integrated oil companies.
<b>Producers Large:</b>	Those who operate, develop and produce 301 or more oil and/or natural gas wells, including producing gas utility companies and integrated oil companies.
<b>Marketers:</b>	Those who purchase or act as agent for producers in the disposition of oil or gas production.
<b>Allied Industry:</b>	Those whose businesses are directly related to the oil and gas industry such as service and supply companies, truckers, sales representatives, or refiners. Also, includes accountants, attorneys, banks, consulting engineers, consulting geologists, geophysicists, landmen and surveyors.
<b>Small Business:</b>	Those small businesses with a maximum of two (2) full-time employees.
<b>Individual:</b>	Those individuals with no company affiliation, employed by governmental agency, or landowners.
<b>Pipeline &amp; Utility:</b>	Oil and gas transmission companies and utilities.
<b>Associates:</b>	Those who are employees of member companies in the Producer, Marketers, Allied Industry, Small Business or Pipeline & Utility category.
